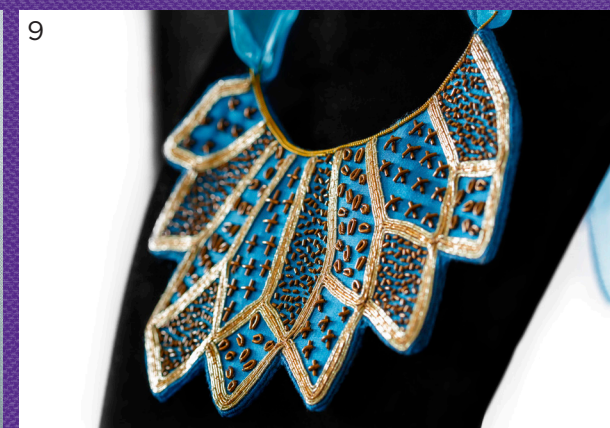
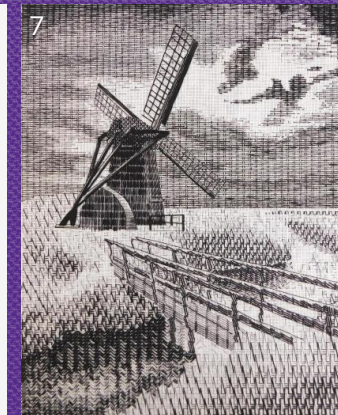

# Why support us?

The Royal School of Needlework (RSN) has a unique mission: training students in the art of hand embroidery to the highest technical level. Founded in 1872, the RSN was originally conceived as a way to provide employment to women who, without a suitable livelihood, would have been compelled to live in poverty. Today, the RSN upholds its founding principles through a diverse educational programme, exhibitions and a commercial Embroidery Studio.

Although many know of the RSN as the international centre of excellence in hand embroidery, fewer are aware that we are also a registered charity (No.312774). We receive no government funding, so we rely on the generous support of individuals and trusts to ensure hand embroidery is both preserved and developed for future generations.

## With your support we can:

- **Continue to teach technical hand embroidery** to the highest level. Graduates of our programmes go on to work across a variety of industries, including ecclesiastical and historical conservation, film, theatre, and fashion.
- **Provide support for our Future Tutors.** This programme trains the next generation of RSN Tutors and Studio stitchers and is not eligible for government grants. Future Tutors are therefore dependent on bursaries and awards to complete their three-year course.



- **Offer bursaries and awards to Degree students.** Our BA (Hons) in Hand Embroidery for Fashion, Interiors, Textile Art, is the only specialist degree in hand embroidery. Friends have helped support individual students.



- **Digitise and catalogue the RSN Collection and Archive** containing over 4,000 embroidered objects and many thousand designs that are mostly in storage. By making them searchable online these amazing resources will be open to a new generation of artists and makers.
